- **9%:** In 2012, President Obama limited U.S. military capability to fighting one "regional conflict" and one "holding action." Defense budgets for 2013-2021 were cut **\$487 billion a 9% cut, at a minimum**.
- 18%: "Sequestration," required by law in 2011, mandates \$500 billion more in 2013-2021 defense cuts an 18% cut, at a minimum. President Obama said he will veto any changes Congress makes.
- <u>Be Prepared:</u> In 2013 these cuts in defense jobs and businesses will hit Oklahoma counties, cities and industries. This report shows how "National Average" defense budget reductions of at least **9% and 18% could affect Oklahoma, using actual 2010 Oklahoma data.**
- <u>Ask Questions:</u> In 2012, Congress and President Obama will decide on the specific defense budget cuts. In the next 6 months, find out if these defense cuts affect your community more or less than this national average. A 2011 nationwide economic impact study from the Center for Regional Analysis predicts that Oklahoma could lose thousands of jobs and hundreds of millions of dollars under the "Sequestration" law:

- Oklahoma could lose 7,326 jobs.
- Oklahoma's economy could lose \$432 million in lost earnings.
- Oklahoma could see a \$629 million decrease in Gross State Product (GSP).

Congressional experts estimate Oklahoma could lose DOD military active-duty and DOD civilian jobs:

- Under "Sequestration," 3,612 military active-duty employees could lose their jobs.
- Under "Sequestration," 5,529 civilian DOD employees could lose their jobs.

Oklahoma businesses will not escape the 9% and 18% cuts.

Public data for 2010 shows Oklahoma businesses earned over \$2.15 billion supporting America's defense:

- But under these 10-year defense cuts of at least 9%, Oklahoma **annual business losses** could be greater than **\$193 million**. Oklahoma businesses may have to **fire workers**.
- And at the "Sequestration" level of at least 18% in defense cuts, Oklahoma **annual business losses** could be greater than **\$387 million**. Some Oklahoma businesses may have to **shut down**.

With at least 9% or 18% in planned budget cuts, Oklahoma's small businesses will suffer.

From 2000-2010, **{TotalBusinesses} Oklahoma businesses** provided goods and services for America's national defense:

- **199 minority-owned businesses**, including 33 owned by Black Americans, 9 owned by Hispanic Americans, 66 owned by Native Americans, 11 owned by Asian-Pacific Americans, and 80 owned by other minority Americans.
- 162 small businesses including 71 "8A" and small disadvantaged businesses (SDB's)
- 198 woman-owned businesses
- 143 veteran-owned businesses, including 45 owned by service-disabled veterans
